Admission to MD/MS/MDS Courses in all Government/Government Aided/Private Unaided Medical/Dental Institutes including those under Private Universities – SGT University, Budhera, Gurugram, PDM University Bahadurgarh, Jhajjar in the State of Haryana for the Academic Session 2020-21.

It is hereby informed that the last date of admission to MD/MS/MDS Courses is hereby extended upto 31.08.2020. It is for information of all concerned that the admission portal for fresh registration will be reopened from **26.08.2020 to 28.08.2020 upto 11.59 PM** for filling up vacant seats for 2nd stray vacancy round. The 2nd stray vacancy round admission to MD/MS and MDS Course in Govt./Govt. Aided Medical and Dental institutions for the Academic Session 2020-21 will be held on **31.08.2020 at 09.30 AM in Committee Room, Director Office, PGIMS, Rohtak.**

All registered candidates desirous to seek admission in 2nd stray vacancy round for admission to PG Courses for the Academic Session 2020-21 are instructed to bring their original Certificates and other relevant documents for verification before the admission committee. Physical presence of the candidate is compulsory. No undertaking will be entertained against any document. The candidates shall have to deposit the original documents & fee in the shape of Demand Draft in favour of "Counselling and Admission on A/C for Department of Medical Education & Research "(**Director Medical Education & Research, Haryana**)" Name of Bank: ICICI Bank Ltd. **Account No. 073205002133 IFSC Code No. ICIC0000732** to the Admission Committee at the time of 2nd Stray vacancy round as notified below failing which their candidature shall not be considered.

For admission in Govt./Govt Aided Institution - Complete fee as per notification dated 15.04.2020.

- The candidates who have taken admission upto stray vacancy round will not be eligible to participate in 2nd stray vacancy round.
- No up-gradation/shifting is allowed. The candidates who have joined on the allotted seats in the All India Counselling/State Counselling shall not be eligible to participate in 2nd stray vacancy round.
- The unfilled seats reserved for category candidates (SC/BCA/BCB/EWS etc) in Govt./Govt. Aided Medical/Dental Institutions will be converted only after giving complete opportunity to the candidates of respective category in 2nd stray round.
- **The candidate who have already registered on admission portal for need not to apply again.**

The filling of MD/MS/MDS Courses in Private Medical/Dental institutes including Private University (SGT University Gurugram and PDM University, Bahadurgarh) of State for the Academic Session 2020-21 will be held in concerned Institutions. All desirous candidates who have registered on web portal are instructed to contact the concerned college for detail information.

The tentative vacant seats position of seats for 2nd stray round for MD/MS and MDS Courses will be available on webportal as well as University website.
